

## CONTEST RULES

### SAFEWAY MY NHL FAMILY™ CONTEST 2019 (the "Contest")

#### 1. Eligibility

The Contest is open only to legal residents of Alberta, British Columbia, Manitoba, Saskatchewan and Northern Ontario\* (the "Participating Provinces") who have reached the age of majority in their province of residence on the date that they entered the Contest. Void where prohibited by law. Employees, directors, officers, representatives, agents of Sobeys Capital Incorporated (the "Administrator" and the "Sponsor"), the National Hockey League ("NHL"), its member teams, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the "NHL Entities") and each of their respective parent companies, affiliates, franchisees, subsidiaries, distributors, representatives, advertising and promotional agencies, agents, sponsors, and any entity that they contract with specific to the Contest, as well as the immediate family members (spouse, parent, child, sibling), and any persons domiciled with any of the above (whether related or not), are not eligible to win a Prize.

\*for the purposes of this Contest "Northern Ontario" will be defined as residences within 75 miles of one of the participating Safeway store locations in Ontario.

#### 2. Contest Period

The Contest runs from 12:00am Mountain Standard Time ("MST") on December 16<sup>th</sup>, 2019 and ends 11:59pm MST on March 1<sup>st</sup>, 2020 (the "Contest Period"). Hours and dates of operation of each Participating Store may vary.

- Contest Period: All entries received from December 16<sup>th</sup>, 2019 to March 1<sup>st</sup>, 2020 will be eligible for the Grand Prize.
- Weekly Contest Period: The Contest Period includes ten (10) weekly contest periods for the Weekly Prizes as set out in the chart below (each a "Weekly Contest Period"). Each Weekly Contest Period begins at 12:00am MST on the period start date and ends at 11:59pm MST on the period end date.

### 3. How to Enter with Purchase

Enrollment in the AIR MILES® Reward Program is required to enter with purchase. If you are not enrolled in the AIR MILES® Reward Program, you may enroll online at [www.airmiles.ca](http://www.airmiles.ca). By enrolling to become an AIR MILES® Collector in the AIR MILES® Reward Program, you agree to be bound by the terms and conditions of the AIR MILES® Reward Program as amended from time to time.

You will be automatically entered into the Contest at the time of purchase at any of the participating Safeway stores located in the Participating Provinces (each a “Participating Store”) in your Participating Region, provided that your AIR MILES® Card is swiped at the checkout and you comply with the entry requirements of these Contest Rules. See Schedule A for Participating Stores in your Participating Region. The following limitations also apply:

- Weekly Prizes: Eligible entries for each Weekly Prize are valid only in the Weekly Contest Period in which the entry is made. Entries for each Weekly Prize will be cleared at the end of each Weekly Contest Period.
- Grand Prize: All eligible entries received during the entire duration of the Contest Period will be cumulatively entered for the Grand Prize.

### 4. How to Enter without Purchase

NO PURCHASE NECESSARY. To enter the Contest without making a purchase visit the Contest website during the Contest Period. The Contest website can be found at the following link:

Read and accept the Contest Rules and comply with the entry requirements of these Contest Rules. Limit one (1) online entry per person, per email address, per week of the Contest Period. The following limitations also apply:

- Weekly Prizes: Eligible entries for each Weekly Prize are valid only in the Weekly Contest Period in which the entry is made. Entries for each Weekly Prize will be cleared at the end of each Weekly Contest Period.
- Grand Prize: All eligible entries received during the entire duration of the Contest Period will be cumulatively entered for the Grand Prize.

## 5. Regional Prizing

For the purposes of this Contest the Participating Provinces will be split into the following four regions: (each a “Participating Region”):

1. Remaining Territory Region: Includes British Columbia, Saskatchewan, Manitoba (outside of the Winnipeg Jets Region), Alberta (outside of the Calgary Flames Region and the Edmonton Oilers Region), and Northern Ontario.
2. Winnipeg Jets™ Region: 75-mile radius from the city limits of Winnipeg, Manitoba.
3. Calgary Flames® Region: 75-mile radius from the city limits of Calgary, Alberta.
4. Edmonton Oilers® Region: 75-mile radius from the city limits of Edmonton, Alberta.

The Participating Region for in-store entries will be based on the location of the Participating Stores within the Participating Region as set out in the attached Schedule A. The Participating Region for online entries will be based on the postal code of your place of residence. However, the Participating Region for all entries and the winner selection for each Participating Region is determined at the absolute discretion of the Sponsor.

† A year’s worth of groceries consists of \$10,000.00 CAD awarded as Safeway gift cards and which is the equivalent dollar value of a twelve (12) month’s supply of groceries based on a grocery purchase once per week with an average retail price of \$208.33 CAD.

The approximate retail value of each Grand Prize is between \$9,600.00 and \$27,000.00 (CAD).

## **7. Secondary Weekly Prize Description**

For the entire Contest Period there are forty-four (44) secondary weekly prizes to be won, which consists of eleven (11) for each Participating Region. Each secondary weekly prize consists of four (4) tickets to a regular season 2020/2021 local NHL® team game selected at Sponsor's discretion, \$100 in Safeway Gift Cards and an NHL® merchandise prize pack valued at \$400 (a "Weekly Prize", and together with the "Grand Prize", collectively, a "Prize"). The approximate retail value of each Weekly Prize is between \$880.00 and \$1,250.00 range (CAD). For each Weekly Contest Period (as defined in section 2 of these Contest Rules) one (1) Weekly Prize will be awarded in each of the Participating Regions.

The following conditions apply to the Weekly Prizes:

- The Weekly Prize has no equivalent cash value, is non-transferable and no substitutions will be made. Weekly Prize must be accepted as awarded. The Sponsor reserves the right to substitute any Weekly Prize for one of equal or greater value for any reason. - Due to the nature of the Weekly Prize, the Weekly Prize must be enjoyed on the scheduled date. The Weekly Prize cannot be rescheduled or substituted once reserved. You must be able physically able to participate in the Weekly Prize in order to be eligible to win.
- If a portion of the Weekly Prize is not used, no compensation will be awarded.
- You must sign the Sponsor's release form (the "Release") in order to receive and participate in the Weekly Prize.
- Any difference between approximate retail value and the actual value of the Weekly Prizes as taken will not be awarded.
- All terms and conditions of the Safeway gift card apply to that portion of the Weekly Prize. Gift Card increments will be allocated at the Sponsor's discretion.

## **8. Odds**

The odds of winning a Weekly Prize depends on the eligible entries received for the respective Weekly Contest Period draw and the odds of winning the Grand Prize depend on the total number of eligible entries received during the Contest Period.

## **9. Draw Details**

Random draws will occur at XMC's head office located at 49 Bathurst Street, Suite 101, Toronto, Ontario from all eligible entries received during each Weekly Contest Period or the Contest Period as applicable (each a "Draw"). The Grand Prize Draw will occur on Tuesday March 3<sup>rd</sup>, 2020. See chart in Section 2 of these Contests Rules for Weekly Prize Draw dates for each Weekly Contest Period. You do not need to be in attendance to be selected. You are only eligible to win a Weekly Prize once however, winning a Weekly Prize does not preclude you from winning the Grand Prize.

#### **10. Winner Contact Details**

If you are chosen to be eligible to win a Prize, you will be contacted within five (5) business days of the Draw by telephone number or email address using the contact information that was submitted in the entry. If you have not provided a telephone number or email address you are not eligible to win the prize. In order to be declared a winner, you will be directed to complete a Release which will be sent through email. You must then correctly answer without assistance a mathematical skill-testing question and sign a Release. The Release must be signed and returned within two (2) days. Upon verification of the completion and correctness of the answer to the skill-testing question, and execution of the Release, you may be declared a winner. In case of a dispute concerning the identity of the individual who submitted an automatic entry with purchase, the entrant will be deemed to be the account holder of the AIR MILES® Collector Account under which the entry was submitted. In case of a dispute concerning the identity of the individual who submitted an online entry with email, the entrant will be deemed to be the account holder of the email address under which the entry was submitted.

#### **11. Forfeit of Prize**

If you cannot be reached within twenty-four (24) hours of our first attempt to contact you, do not answer the skill-testing question correctly, or otherwise fail to comply with these Contest Rules, then the Prize will be forfeited and another entry will be randomly selected from among the remaining eligible entries as per these Contest Rules. This process of selecting a Prize winner will be repeated until all Prizes eligible to be won have been awarded.

#### **12. Use of Personal Information**

By entering the Contest and voluntarily providing your personal information as described in these Contest Rules, you agree to the collection, use and disclosure by the Administrator, and its respective employees and/or authorized agents, of your personal information, for the purpose of administering the Contest, including—but not limited to—contacting you with respect to the Contest if you are a selected entrant. Personally-identifiable information will only be used to administer the Contest and for no other purpose, except as specifically outlined in these Contest Rules. Personally-identifiable information will not be sold, shared or disclosed by the Administrator to any third party, other than to a third party engaged by the Administrator for the purpose of administering the Contest, or if required by law with the exception that aggregated information may be used by or shared amongst the Administrator and its subsidiaries and affiliates, or shared by the Administrator with third parties in accordance with our Privacy Commitment available at <https://www.sobeys.com/en/privacy-policy>.

#### **13. Publicity Consent**

By entering the Contest, you agree that if you are determined to be a winner, the Administrator and the Sponsor may use your name, comments, voice, likeness, municipality of residence and picture in any advertising, promotion or publicity carried out now or in the future, in any media without compensation or notice, and you grant to the Administrator and the Sponsor any and all rights to such use. You agree to cooperate with the Administrator and the Sponsor in arranging for photographs or other forms of publicity and to be available for photographs or other forms of publicity on reasonable notice.

#### **14. Limitation of Liability / Release**

By entering the Contest, and as a condition of acceptance of the Prize, you, your heirs, executors, administrators, legal person representatives, successors and assigns, agree, among other things, to hereby irrevocably and unconditionally release and forever discharge and hold harmless LoyaltyOne Co., the NHL Entities, Sobeys Capital Incorporated, Calgary Sports and Entertainment Corporation as general partner for and on behalf of Calgary Flames Limited Partnership (the "Calgary Flames"), Edmonton Oiler Hockey Corp. in the Contest or by any technical or human error which may occur in the processing of entries in the Contest, nor for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of entries; and, are not responsible for any problems, failures or technical malfunction of any telephone or network lines, computer online systems, servers, providers, computer equipment, software, email, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website or on account of any combination of the foregoing; and are not responsible for any injury or damage to entrants or to any computer-related injury or damage resulting from participating in downloading materials in this Contest.

In the event that, due to a printing, manufacturing, mechanical or other error of any kind or nature whatsoever, more Prizes are claimed than are intended to be awarded according to these Contest Rules, Prizes will stop being awarded when the Administrator becomes aware of an error respecting the number of Prizes and the Administrator reserves the right, in their sole and absolute discretion, to conduct a random draw from amongst all eligible and approved Prize claimants whose claims have not yet been redeemed to award the remaining number of advertised Prizes. In no event will the Sponsor or Administrator be liable for more than the stated number of Prizes contained in these Contest Rules.

#### **17. Rights to Terminate/Modify/Suspend Contest**

The Administrator retains the right, in their absolute discretion, to suspend, modify or terminate any aspect of the Contest (including, but not limited to these Contest Rules) at any time. The Administrator may make substitutions of equivalent kind or value in the event of the unavailability of a Prize (or component thereof) for any reason whatsoever. The Administrator may terminate or withdraw this Contest at any time by posting a notice at the Participating Stores. If the Contest is terminated on any day prior to the normal Contest end date (the "Termination Date"), the Administrator and Sponsor may determine the winners from all eligible entries received as of 11:59pm on the Termination Date (which winners shall be randomly selected in accordance with these Contest Rules).

#### **18. General Disqualification**

Any attempt made by an entrant or other individual or entity, to deliberately damage, manipulate or undermine the legitimate operation of the Contest, including but not limited to any fraudulent claims, is a violation of the law. The Administrator and Sponsor reserve the right to seek remedies and damages from any such individual or entity which makes any such attempt. Any entrant who, in the opinion of the Administrator, is determined to be engaging in any of the foregoing activities will be immediately disqualified from the Contest.

#### **19. Role of Parties**

LoyaltyOne Co. and the NHL Entities are not responsible for the sponsorship or administration of this Contest. Entrants acknowledge and agree that the NHL Entities, the Calgary Flames, the Edmonton Oilers, Winnipeg Jets and True North's role in the Contest is strictly that of supplying a prize and that the Sponsor and Administrator alone is fully responsible for the conduct and administration of each and every aspect of the Contest, including the selection of winners and the distribution of the Prize. Sobeys Capital Incorporated is the Sponsor and Administrator of this Contest.
